What Next

Our current strategy 2013-2015 has reached its conclusion, so our Strategy 2016-2018 will be finalised and compiled with a launch date in July. Children remain at the centre of our work and in 2016 we will continue to engage with policy makers, focusing our policies on ending child poverty. In 2016, our Professional Development Service will be redeveloped and expanded to include new workshops to support the building of the knowledge, skills and approach of service providers who work with children, parents and families, or in crisis pregnancy services. We will also continue to work towards attitudinal change; challenging stereotypes and highlighting one-parent family role models. Our annual Family Day, as a day of acknowledgment and celebration for all children irrespective of their family form, supports these aims. We expect even greater numbers to attend in 2016 and, to this end, we will seek partners and collaborators to grow the event.

Social welfare reforms continued to have seriously detrimental effects on oneparent families in 2015 as we saw more parents having to leave part-time work due to stricter requirements of the new payments. In February, we presented our SMART action plan for Reform of the One Parent Family Payment (OFP) to the Joint Oireachtas Committee on Education and Social Protection. Our Pre-Budget Submission for 2016 sought changes to ensure work pays for parents on social welfare and some of our recommendations in relation to income disregard were accepted. We continued to call for the provision of affordable, accessible and quality childcare, which remains the greatest barrier for lone parents in returning to the workplace or education.

We were delighted to see the Children & Family Relationships Act become law as we had worked hard on ensuring that the reality of family diversity is recognised and that children are protected in all the different families they live in. We launched our six point General Election Manifesto in December so that our members, clients and the families we represent could directly lobby election candidates to ensure that the voices of one-parent families were heard.

We are proud to be recognised as Ireland's expert voice and opinion on issues affecting people parenting alone, sharing parenting, and separating and we continued to work in partnership with stakeholders within Ireland and across Europe. We served on the Advisory Council on Better Outcomes, Brighter Futures: the National Policy Framework for Children and Young People 2014-2020; participated in the European Families & Societies project; and had a leading role in the development and delivery of the Civic Forum on One-Parent Families with now Minister for Children & Youth Affairs, Katherine Zappone.

One Family's voluntary Board of Directors continue to place strong emphasis on governance and financial management. I thank our funders and donors for their continued support. I also thank our volunteers, supporters and staff members, who remain dedicated to creating a positive and equal future for all members of one-parent families in Ireland.

One Family continued to expand our range of specialist family support services for people parenting alone, sharing parenting, and families who are separating. Our counselling services remained in constant and high demand. Our national askonefamily helpline had its busiest year yet with another 20% increase in call volume since 2014. This was mostly due to the radical social welfare changes for parents in receipt of the One-Parent Family Payment whose youngest child reached the age of seven years old.

Other issues of concern to parents included family law changes, particularly for unmarried fathers; practical information and emotional support for separating parents was frequently sought; as was social welfare information for low-income working parents seeking to maximise their income amid changes and cuts.

We continued to grow our Parenting Support Services, expanding the locations where we provide individual parent mentoring services. We also ran a new online parenting programme and established a new Facebook group just for parents. Despite ongoing funding challenges to our Childcare service we have invested in additional qualified staff to ensure high standards are maintained and we experienced a successful Childcare service inspection by the HSE. Having been awarded National Lottery Funding, we also facilitated free Professional Development programmes for professionals working with young people and in family support.

In May, we celebrated Family Day with our fifth annual Family Day Festival attended by 5,000 people. We offered a busy programme with free and low-cost events for parents and children throughout the Summer, while in December our Winter Party was attended by happy children and parents in the historic Dublin Castle.

I would like to thank our dedicated and hard working staff members, volunteers, and the Board for their continued efforts in providing the much needed services of One Family. It remains a privilege to work with and on behalf of the diverse group of people who make up one-parent families in Ireland.

OUR WORK, AND THE FAMILIES i WE WORK WITH AND FOR

One Family works under **Strategy 2013-2015** which is available on www.onefamily.ie. Annual work plans are devised for each service of the organisation based on the strategy and all staff members are monitored accordingly.

We organise our strategy into three ambitious objectives because by 2020 One Family will have achieved the following:

- The Constitution and legislature will have recognised and afforded respect to all family forms and structures including one-parent families;
- Poverty rates for one-parent families will be significantly lowered and will be comparable to that of the general population: and
- One-parent families will be widely recognised. understood and celebrated as positive family forms.

IRELAND IN 2015

- There are over 215,000 one-parent families in Ireland today - 25.8% of all families with children (Census 2011).
- 1 in 4 families with children in Ireland is a one-parent family over half a million people.
- 52.4% of lone parents are in the labour market and the unemployment rate for lone parents is 14.7%.
- Employment rate of lone parents (aged 15-64) with children under 5 years is 42% rising to 49.7% where the youngest child is aged 6 to 11, and 63.2% where the youngest child is aged 12 to 17. This indicates that, as children get older, the prohibitive costs of childcare are reduced and lone parents are more likely to engage in work.
- 42,104 people are now receiving the One-Parent Family Payment (OFP). This has decreased from 92,326 in 2010. 25,500 exited the OFP scheme on 2 July, 2015.
- The Survey on Income and Living Conditions (SILC) 2014, revealed that one-parent family households experience the most deprivation (inability to afford two from a list of 11 basic necessities) in Ireland.
- Children living in one-parent family households are almost twice as likely to live in poverty than other children - 23% of children in a one-parent family experience deprivation (SILC 2014).
- Furthermore, almost 60% of lone parent households experience more than one form of deprivation (SILC 2014).
- 11% of children aged 0-17, or 1 in 9 children, live in consistent poverty (SILC 2014). This can mean going 24 hours without a substantial meal.
- One-parent families continue to have the lowest disposable income out of all households in the state (SILC 2014).
